



## INTERNATIONAL LAW BREACHED AS TURKISH LAWYERS ARRESTED

### JOINT STATEMENT: BAR HUMAN RIGHTS COMMITTEE AND BAR COUNCIL

*Bar Human Rights Committee and Bar Council of England and Wales express deep concern over attacks against lawyers in Turkey*

**22 March 2016**

The Bar Human Rights Committee of England and Wales (BHRC) and The Bar Council of England and Wales are extremely concerned to hear reports of raids on the houses of nine lawyers in Istanbul in the early hours of 16 March 2016.

After the search, lawyers Ramazan Demir, İrfan Arasan, Ayşe Acinikli, Hüseyin Boğatekin, Şefik Çelik, Adem Çalışçı, Ayşe Başar, Tamer Doğan and Mustafa Ruzgar were taken into custody. The lawyers are human rights lawyers and members of the Libertarian Lawyers Association (Ozgurlukcu Hukukcular Dernegi – OHD). The lawyers arrested are known for their work in representing people accused of crimes against the state, terrorism and in the protection of minorities.

Many of these lawyers have been engaged in the representation of another group of 47 lawyers who are now being prosecuted on charges alleging association with a terrorist organisation. The charges relate to carrying out legal representation of alleged terrorists. Many of those lawyers were held in pre-trial detention for 14 months, despite their professional status and strong community ties.

BHRC has been engaged in observing this trial since 2012 and has registered concerns that unless many features of the trial are remedied, the lawyers will be denied a fair trial according to internationally agreed standards.

The United Nations Special Rapporteur for the Independence of the Judiciary and Lawyers visited Turkey in October 2011. She expressed her deep concern about the rising number of arrests, detentions and prosecutions under terrorism related charges of lawyers defending individuals accused of terrorism-related crimes. Since her visit the number of arrests has risen exponentially.

The mass arrest of these lawyers appears to be in breach of the United Nations Basic Principles on the Role of Lawyers. Principle 18 provides that lawyers shall not be identified with their clients or their clients' causes as a result of discharging their functions, and principle 20 affirms that lawyers shall enjoy civil and penal immunity for relevant statements made in good faith or in their professional appearances before courts and tribunals.

BHRC is concerned that these principles are increasingly being breached in Turkey and that lawyers are being prevented from performing their professional functions without improper interference, or, worse, arrest for affiliation with their clients' causes.

Turkey has ratified the European Convention on Human Rights (ECHR) and the International Covenant on Civil and Political Rights (ICCPR), both which enshrine the right to a fair hearing and which includes the right to legal representation. By arresting and trying lawyers, the right to effective legal representation is being denied to those charged under anti-terrorism legislation. Moreover, their lawyers may face conviction for simply performing their professional obligations.

BHRC and the Bar Council further express their deep concern about reports that riot police assaulted lawyers who were representing their detained colleagues during a press conference outside the court room. The assault was witnessed by members of an international delegation of lawyers, including lawyers from the UK, who were observing the trial of the 47 lawyers. It appears that the assault was unprovoked. BHRC and the Bar Council deplore the use of violence against our professional colleagues in Turkey.

BHRC calls on the Turkish Government to comply in full with its obligations under Article 6 ECHR and Article 14 ICCPR, and to implement the UN Basic Principles on the Role of Lawyers. It also calls upon the Turkish authorities to bring forward a reasoned case against the arrested lawyers as soon as possible, and to afford them an effective right to bail, in accordance with Article 5 ECHR.
